Good afternoon:

I am forwarding the KUA permit applications to Building Inspector David Lersch this afternoon for final review and issuance.

I strongly encourage KUA to keep in close contact with your life safety code consultant during the project's construction. When the buildings are materially complete the town will ask the Fire Marshall to join us on a walk thru of the building prior to issuing certificates of occupancy. Doug Plummer is familiar with this process as we have done it many times in the past. Its not a time to learn about new issues.

On at least one occasion, non KUA project, Â that I am familiar with the Fire Marshall had a different interpretation of the code than the project's design team. In the end, there was only one code interpretation that matter, that of the Fire Marshall. Public buildings are not easy!

You should have your permits from Dave in the next 24 hours. A Let me know if I can help. Its going to be a busy summer on Main Street.

Hi Steve

To keep things moving on our end KUA would be okay with a Conditional upon Fire Marshall review permit, especially with the level of consultant expertise and their issuance of stamped drawings.

The A/E team has included fully sprinklered fire protection as well as assembly ratings that have been reviewed and accepted by a third-party code compliance firm. If modifications are required from the State Fire Marshall's office we can implement as required during the course of construction - The first 4-6 month of construction is primarily site, concrete, structure and weather tight components, - This timeline would be more than enough to address any Fire Marshall comments without impeding construction start.

I would be happy to meet with you and VIA to discuss further.

Kimball Union is set to begin construction on two new dormitories next month. Early on in the project, (Jan 2023) I suggested that the architect reach out to the Fire Marshall's Office to assure compliance with the life safety codes. I do not have the necessary expertise for a project of this size and complexity. They have hired Bergeron Technical Services to review the plans. Bergeron sent a letter to your office on 5/18/23 that basically says that they believe the project as designed meets all of the necessary codes and that they would like the Town to issue the building permits. Is this enough of a review for the permits to be issued or should your office get involved and do any further review of the plans?
