**Plainfield Zoning Ordinance Changes 2016**

**Are you in favor of the adoption of amendment #1 to the Plainfield Zoning Ordinance as proposed by the Planning Board?**

**Amendment 2.** In order to clarify what is meant by the term Impervious Surface the following change is proposed: **Add** to Article VIII of the Zoning Ordinance-Definitions the following: **Impervious surfaces:** Surfaces that cannot effectively absorb and infiltrate water and therefore increase both the amount and rate of storm water run off. Examples of impervious surfaces include, but are not limited to driveways, parking areas, sidewalks, roofs, decks, and patios. Vegetative surfaces are not considered impervious.
