I am in a discussion group on Religion and Politics that was set up through the NH Humanities Council...we have been discussing religion in the White House, euthanasia, civil unions, etc...it is never boring. I have been told by one member of the group that I am not married, we have a civil union...Jon and I have no children by choice...that is fine.

One Bill that I am following is HB267 in Commerce. That Bill is about the Pay Day Lenders...predatory lenders to be exact. Pay Day loans often cause repeat borrowing, leading to a debt trap that is very difficult to get out of so that you can move forward. For starters it needs to have a cap and that has been discussed to be 36% as opposed to the 1000% that can result in taking out these EMERGENCY loans. Please, when you are in an emergency situation please talk with your town office, your church and other programs that may be able to help you before resorting to a loan that will possibly put you in to perpetual indebtedness. Many of our Welfare recipients are the result of payday loans so this becomes a societal problem! Please go on line and read about this issue and contact the Representatives on the Commerce Committee with your thoughts. Matthew Houde is on Commerce so we are lucky!

I know that many of you are wondering why we are not getting paved...I did get a DOT map that shows all of the projects for 2007 and we are not in the loop for new pavement...Matthew and I can not take any blame for that...it was before our time!

I have introduced a Bill addressing necessary shelter for dogs...Petey, Darla, Cladia, my friend Heidi Jones and I went in to Concord last Sunday for the Million Dog March which was held at the State House...we were pleased with the support we had and had a fun day though it was very cold. The Bill deals with protection from the elements, dry housing and safe conditions for our "Best Friends"!

Be sure to look in the local papers for flu clinics...and do think about getting your pneumonia vaccination...call your doctor if you have any questions!
