### Dear Mr Halleran:

National Grid hereby respectfully requests the Plainfield Planning Board approval to trim and remove trees on Black Hill Rd, Pierce Rd and River Rd, all designated scenic roads.

The tree work proposed is part of National Grid's routine scheduled maintenance program, which seeks to provide safe and reliable electric service to our customers. The roads will be trimmed and trees under 5" diameter directly under the power lines will be removed, as in the past. All work will be in accordance with standard arboricultural practices. All brush will be chipped and wood will be left piled roadside.

All property owners will be consulted to approve of the proposed work before the hearing, where the trees are located on private property.

Pierce Rd has no tree removals required, just trimming and removal of under 5" diameter trees. The table below lists trees over 5" diameter that we request to remove. The table corresponds to the attached maps with a letter designation for reference. All requested tree removals are marked with ribbon on the trees. A = Black Hill Rd from the dead end to Beauty Hill Rd. B = River Rd from Pierce Rd to Freeman Rd, and C = River Rd from Pierce Rd to Rt 12A






