PUBLIC NOTICE**

You are hereby notified that **Anne Gallagher** has filed an application for an annexation. The proposal involves the transfer of 2.7 acres from tax map 264-15 to tax map 264-09. Both lots are owned by the applicant. As a result of this project tax map 264-15 will be reduced to 100.6 acres and tax map 264 lot 9 will be enlarged to 12.3 acres. Both parcels have road frontage on Camp Road and are located in the Rural Residential (RR) zoning district. Neither is served by public water or sewer.

If the Planning Board determines that the application has been completed in accordance with town regulations, the Planning Board will conduct a public hearing to hear evidence on whether or not to approve the annexation at their meeting:

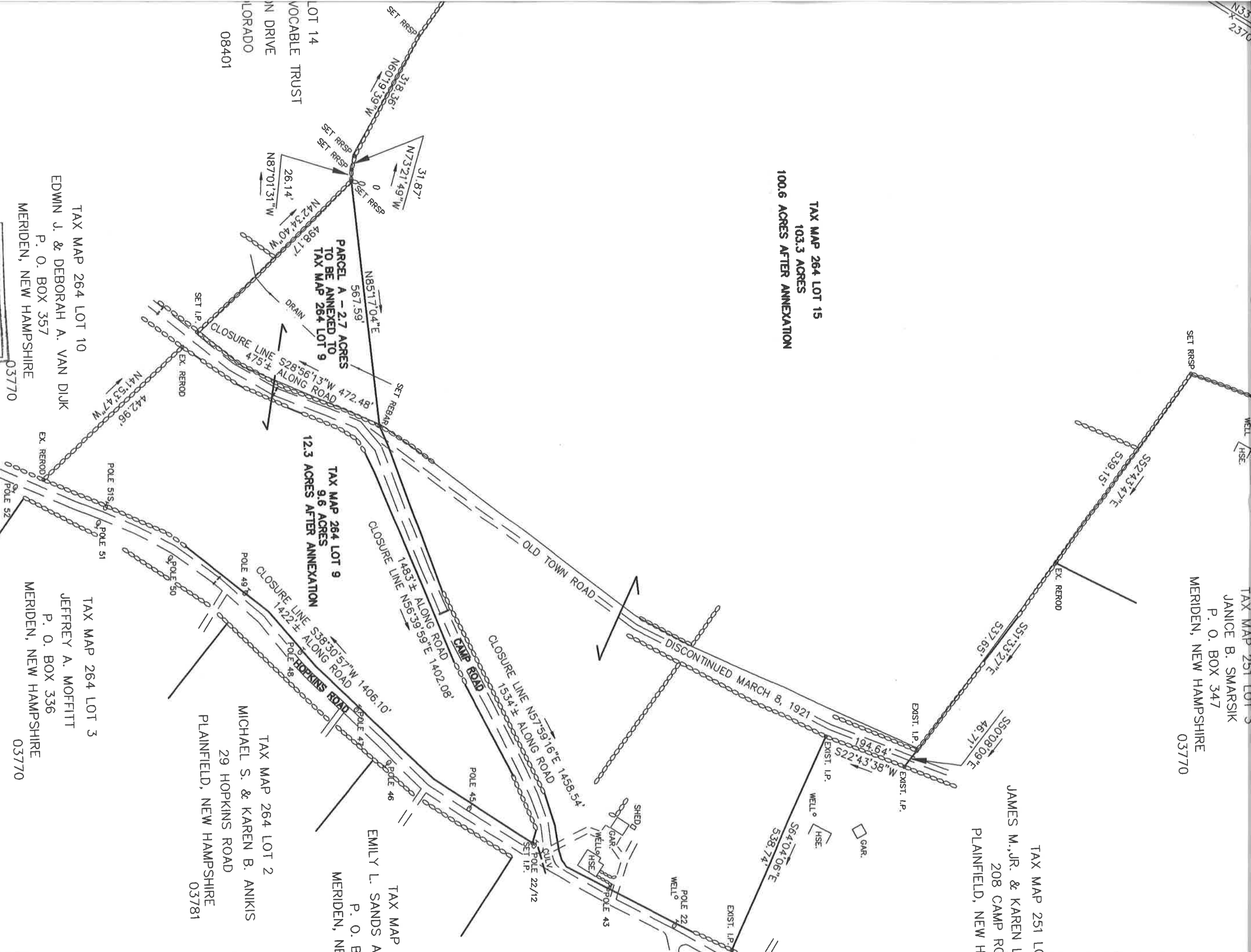

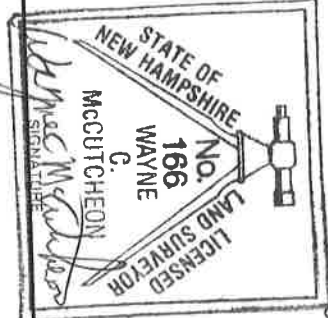
