NEW MERIDEN LIBRARY: Suzanne Spencer/Rendahl and Brad Atwater presented an energy use/efficiency plan for the proposed new library. The Bensonwood Builders are known for their building integration, tech knowledge and energy efficiency. Cap of \$1 million, will be 45% larger, less energy usage and should cost less for utilities. The Plainfield Committee will discuss and get back to the Library Committee with an endorsement consistent with Town philosophy/RF100.

WEATHERIZATION: All set for the 22nd. We will need two computers for trying out NHSaves website, Resource table for handouts - STEVE. NANCY. ABC will also join us as a contractor. Financing? STEVE? Neighboring communities also invited. Be there at 6:30 if you can.

Clarification for NHSaves square foot requirement: Square Footage means ALL finished rooms. Upstairs, downstairs and basement if finished.

PLAINFIELD SOLAR WARRANT ARTICLE: Will be tabled to next year. Too late to for Planning Boaard Meeting.

NEW HAMPSHIRE RESOLUTION FOR CLIMATE ACTION (Carbon fee, cash back petition): 66 Towns are gathering signatures for this petition. Some push back from Legislature on this, but whatever happens, it shows support from constituents that action is necessary.

COMMUNITY POWER (community aggregation): Evan attended a "Local Govt. Community Power Meeting" held in Concord on Dec. 20 - Well attended by several towns. The meeting was to work out a business agreement for Towns to work together. At this time, community aggregation is basically an accounting operation of choosing energy for a town but receiving one bill from one's Utility Co. Potentially cheaper but there are differences for net metering residences and for those without solar. Those with solar would probably opt out. Lebanon will launch this year, Hanover and Keene next year. Aggregation is successful in CA and in a region in MA. Selectboard will appoint a committee and the committee will develop a plan for 2021.

At this time, community aggregation is basically an accounting operation of choosing energy for a town but receiving one bill from one's Utility Co. Potentially cheaper but there are differences for net metering residences and for those without solar. Those with solar would probably opt out. Lebanon will launch this year, Hanover and Keene next year. Aggregation is successful in CA and in a region in MA. Selectboard will appoint a committee and the committee will develop a plan for 2021.

Next Power Meeting, January 10, 1 pm to 2:30 pm. EVAN will send our information to join via internet.

Tabled EDUCATION SERIES planning for next month. Long discussion on Lebanon's Battery Program. Doug Heaton requested info from Liberty on this program and it seems that he will lose his net metering rights. Joanna and Evan both had different info on this: Evan from Lebanon meetings and Joanna from Liberty. Doug says he will take it to the next level and sign up. He'll let us know what happens! - Minutes of Previous Meeting Dan moved to approve, Joanna seconded. Minutes approved.
- 2. Dean Berg Green House Gas (GHG) emission-reducing app prototype ready around January. March/April app will be ready. 65-85%GHG are human derived and dependent on fixed resources. The app engages public on a more relational level to change behaviors toward more energy efficient ones. Different approaches are used. Community involvement to accelerate town initiative (Ready for 100, for example); app features is customized to the town. Provides incentive to reduce GHG emissions. Businesses in the towns would offer a coupon as residents accumulate points to be redeemed. It encourages participants to buy local (sustainability standpoint) Green actions = carbon points. Dean showed some of the screens on the app. Behavior changes because you can see points accumulate, perform suggested actions which introduces other energy efficient possibilities. Then redeem these carbon points. How do the actions get verified? Based on honor system. Validated by different ways. Can scan QR code to confirm the participant did the suggested activities. For example, went to a local farmers market, or watched a specific video, or read a specific article. (20 total screens are in the app but basically 3 or 4 core screens. Redeem points at local businesses. Pilot: Lebanon in midsummer. Upper Valley pilot. It was suggested to Dean that the app be offered as far south as Claremont. Offered to renters and homeowners and limit to 80-100 businesses (diverse set). How much reduction can possibly be accomplished in 3 mos.? Data is aggregated. Verifiable grams of carbon reduction. Can then determine which neighborhoods are primarily driving the GHG reduction program the best or which have the most participation. First, start with baseline carbon footprint using public data and justify by people in the household. Don't want to put a roadblock right away with lots of paperwork and pages of survey questions. App will use a default specific to the town. THEN feed some survey questions to the users. Hope to get people to fill out enough questions eventually to gather good data. Exploring upscale versions. The Chamber is on the committee. Looking for towns in upper valley to participate. Works with Vital Communities. Questions to be sent to Dean. Just doing planning meetings now. We can join in January or maybe later. Roll out Upper Valley pilot in April.
 - a. Email from Jon Chaffee from Sustainable Lebanon to Joanna:
 - b. "Sustainable Lebanon is participating in an Upper Valley pilot of a mobile phone app designed to engage citizens in reducing their greenhouse gas emissions and enable them to obtain rewards for their actions as discount coupons at participating businesses. We hope to enroll 300 or so residents for 3 months starting in April or May 2021. If it works well, if there are reductions in the range of 20%, and there is good participation from households and businesses, we would roll out a full scale engagement of citizens some time in late 2021.

Sustainable Lebanon sees this as a way to reach out to our mailing list of Lebanon Residents. Sustainable Woodstock is participating. Vital Communities. There is a working advisory committee. Hanover said they are too busy. Norwich just dropped out (it was a little too pilot for them at this point) and Hartford is in disarray without a point person. I was keeping it simple until this development, but I'm now getting in touch with you to see if you think Plainfield might be interested in the pilot.
